- **U.S. EPA 40 CFR Parts 260 - 282**
 - *Adopted by Arizona via EPA Authorization*
- **Arizona Administrative Code R18-8-260 to 280**
 - *ADEQ to PDEQ in Delegation Agreement*
- **Arizona Revised Statutes, 49-107, 11-201(A)(3), 11-952**
 - *Allows ADEQ Delegation PDEQ*
- **Delegation Agreement, 06-0027 (June 2007- June 2011)**
 - *Part of Agreement Since Mid-1990's*
- **Pima County Code Title 7, Chapter 9**
 - *Pursuant to Arizona Revised Statutes 49-112(A) & (B)*
 - *(7.09.090) Registration Fees*
